LAW FOUNDATION OF NOVA SCOTIA

The Law Foundation of Nova Scotia was established in 1976 by amendment to the *Barristers' and Solicitors' Act* (now *The Legal Profession Act*). Its central purpose is to receive and distribute interest earned on lawyers' pooled trust accounts in accordance with its mandate.

A Board of Governors, consisting of up to nine members, administers the Foundation. The Board meets 4-5 times per year and reviews applications at its winter meeting. The Governor in Council appoints up to five members. The Nova Scotia Barristers' Society appoints four. This year, the members of the Board were:

The Governor in Council appoints the Chair from the members of the Board, upon the joint recommendation of the Attorney General and the Nova Scotia Barristers' Society. Currently, the Chair is Robert G. MacKeigan, Q.C.. The other officers of the Board are A. Robert Sampson, Q.C. - Vice-Chair, Margaret MacKenzie - Secretary and M. Gerard Tompkins, Q.C. - Treasurer.

The Foundation employs two part-time staff members:

MANDATE

The objects of the Law Foundation are "to establish and maintain a fund to be used for the examination, research, revision and reform of and public access to the law, legal education, the administration of justice in the Province and other purposes incidental or conducive to or consequential upon the attainment of any such objects."

CHAIR'S MESSAGE

These have been challenging financial times for the Law Foundation. In 2011-2012, for the 3rd year in a row, the Law Foundation used reserve funds to ensure consistent support for its grantees.

The Foundation's primary source of income is the interest earned on lawyers' trust accounts. As a result, the Foundation's revenue fluctuates with the prime rate. The prime rate of interest stayed consistently low (3%) throughout the past year, resulting in trust account revenue totalling \$796,307. This is up from \$471,558 in 2010-2011, when the prime rate was 2.25% at the start of the fiscal year, rising to 3% by year-end.

The coming years will likely continue to be lean financial ones for the Foundation as revenue from interest on trust accounts is not likely to increase throughout 2012 and 2013. In February 2012, the Board approved nineteen grants totalling over \$1.1 million to be disbursed throughout 2012-2013. This is a decrease from twenty-four grants totalling over \$1.5 million disbursed in 2011-2012. For 2012-2013, no new grants were awarded, a small number of grants were denied and practically all remaining applicants received less than the amount requested in their applications. The decision to decrease, and in some cases deny, applications was a very difficult one for the Board but the long-term sustainability of the Foundation necessitated tighter restraints. Because trust account revenues were lower than the approved grants, and the value of the investments had decreased, the Foundation's reserve was reduced by close to \$750,000 in 2011-2012 and will likely decrease again during 2012-2013.

We are proud of our grantees who continue to do important work providing Nova Scotians with access to legal information and assistance. We hope that in the coming year the world economy stabilizes and improves, allowing us to, once again, consider increasing our support. A number of our grantees received special recognition this year for their work and we are pleased to highlight a few in the AWARDS & RECOGNITION section below.

This was also a year of change for the Foundation.

We welcomed Paulette Anderson, from New Glasgow, to the Board this year. Paulette brings a great deal of experience and a rural community viewpoint that have already added greatly to the discussions of the Foundation. Following a long career with the Departments of Community Services, Housing and Consumer Affairs, providing the delivery of programs and services to a broad spectrum of Nova Scotians, Paulette became involved with the voluntary sector. She became a Public Representative for the Nova Scotia Barristers' Society for a period of five years, serving the Society on various committees and in various roles. The Foundation is fortunate to have her join the Board.

Toward the end of the fiscal year, the Foundation was notified by its landlord that its offices were to be moved to allow for expansion of a neighbouring tenant. As a result, preparations are underway to relocate the Foundation's office to a smaller space on the 13th floor of Cogswell Tower at the beginning of May 2012.

During the year, the Foundation's Executive Director, Kerry Oliver, began a 14-month leave of absence and we are very fortunate that Karen Hollett agreed to be the Acting Executive Director during Kerry's absence. I would like to express my appreciation to Kerry, Karen and Kathy Samson for their extra efforts in preparation for, and during, Kerry's absence and for their diligent work throughout the year.

I would also like to take this opportunity to sincerely thank the members of the Board for volunteering their time and generously contributing to the work of the Foundation and access to justice in Nova Scotia. Without their support, the work of the Foundation would not be possible.

REVENUE


The Law Foundation's ability to make grants depends on revenue generated primarily from interest on lawyers' pooled trust accounts. The Foundation keeps these funds invested until distribution. Trust account revenue fluctuates with the balances in the trust accounts and particularly with the prime rate of interest.

Changes in the prime rate of interest can produce dramatic results. The Foundation has seen its revenue from interest on trust accounts change from over \$4 million in 2007-2008 to \$331,560 in 2009-2010 and \$471,558 in 2010-2011. In 2011-12, the prime rate remained consistent at 3% throughout the year, resulting in trust account revenue of \$796,307.

RESERVE

Fluctuations in the Foundation's income are reflected in the amount of money available to be awarded in grants. It was recognized early in the Foundation's history that a severe decline in the prime rate could force the Board to reduce or terminate grants. To help protect against this, the Foundation established a reserve in 1986 to be used to maintain regular grants in periods when low interest rates result in insufficient income to fund grants.

For the past three years, the Foundation has used monies from its reserves to maintain as consistent support as possible for the grantees. During 2010 – 2011, the Foundation's reserves were decreased by over \$500,000 in order to help grantees survive the downturn. During 2011 – 2012, the Foundation's reserves were further reduced by close to \$750,000.



In considering grant applications for the 2012-2013 year, the Board became increasingly concerned with the sustainability of the Foundation. Large draws on the reserves over the past number of years, coupled with indications that the prime rate will likely remain at 3% throughout 2012 and 2013, resulted in the Board making difficult decisions about some of the applications before it. The Board has approved grants in excess of \$1.1 million to be disbursed in 2012-2013. Even with reductions in grants, the Foundation will have to once again use its reserve funds to sustain the grants that have been approved.

At the beginning of this fiscal year, the reserve totalled \$3,595,105. As of March 31, 2012, the reserve was \$2,848,553. There was a deficiency of trust account revenue over grants disbursed during 2011-2012 totalling \$752,773.

FUNDING GUIDELINES AND APPLICATION PROCEDURES

The Board strives to be accountable in the distribution of funds received by the Foundation from interest accruing on lawyers' pooled trust accounts. The Board endeavours to be transparent and consistent in its evaluation of applications. It takes into consideration where programs will operate and who will benefit from them, as well as whether they fit within the Foundation's mandate. Accountability extends to the careful assessment and consistent monitoring of programs that receive funding.

GRANT BALANCES REPAID AND UNDISBURSED

During the period April 2011-March 2012 there was an undisbursed balance on the Society of Deaf & Hard of Hearing Nova Scotian's grant of \$ 1622.42. As well, during this period the Schulich School of Law - Indigenous Blacks & Mi'kmaq Initiative repaid \$19,500 of its 2010-2011 grant.

GRANTS AWARDED AND GRANTEE PROFILES

Since its creation in 1976, the Foundation has received approximately \$37.3 million in revenue from interest on lawyers' trust accounts, and has awarded over \$35 million in grants. More than \$2.6 million has also been awarded in scholarships during the past 20 years. These grants and scholarships have promoted improvements in the law, excellence within the profession, and have helped more than 250 organizations make the law more understandable and accessible to the public.


In February 2012, the Board approved grants totaling \$1,102,428 for 2012-2013.

Halifax Refugee Clinic

The Halifax Refugee Clinic received the Legal Information Society's **Honourable Lorne Clarke, Q.C. Access to Justice Award** for its excellent work in promoting access to justice for refugees. The Clinic, through a small staff and a group of dedicated volunteers, provides refugee claimants with invaluable advice and assistance as they face the refugee application process. Clients also receive assistance with work permits, housing, budgeting, English language skills and access to health care and psychological support.

The LISNS Awards Committee members said they were impressed with the staff and volunteers' passion for the program and their commitment to help some of the most vulnerable people in society. Many lawyers volunteer time to ensure that refugee claimants have access to legal services and to mentor law students.

Educational Program Innovations Charity Society (EPIC)

EPIC Society, from North Sydney, Cape Breton, was a multiple award winner from the Donner Foundation this year. EPIC runs the Youth, Peer and Parents PEACE which is an after-school program for youth at risk. The program addresses social and academic challenges by matching participants, one-on-one, with older youth volunteers who engage them through tutoring, mentoring, art, music and educational games. Twenty-two community agency partners refer youth to this program which is supplemented by practical workshops to help parents enhance their interactions with their children.

The Society:

- won the \$5,000 Donner Award in the *Services for Children* category
- is considered 1 of 8 "consistently high performing organizations" in Canada for 2011
- scored highest in the country for financial management

Elizabeth Fry Society Mainland

Elizabeth Fry Society Mainland was the recipient of a **2011 Minister’s Award for Leadership in Crime Prevention** for Our Thyme Café. The Society supports women and girls involved in the criminal justice system. Our Thyme Café provides a wonderful training experience to strengthen the opportunity for a successful reintegration into the community.

Leave Out ViolencE (LOVE)

By addressing violence as something that is learned and cyclical, LOVE works with victims, perpetrators and witnesses of violence to deliver programming that is preventative and interventional.

LAW FOUNDATION SCHOLARSHIP FUND

The Foundation established a trust fund in 1981 with an initial grant of \$200,000 to provide scholarships to students attending Schulich School of Law at Dalhousie University. There have been several contributions by the Law Foundation to the fund over the years when revenues were more plentiful. The fund provides scholarships for students entering first year, renewable in second and third years. These undergraduate scholarships were valued at \$16,000 for the academic year commencing September 2011. The fund also provides fellowships at the graduate level.

Our responsibility, in accordance with the applicable Assurance Guideline of The Canadian Institute of Chartered Accountants, is to report on the summarized financial statements.

In our opinion, except for the effect of the adjustments, if any, had interest credited by financial institutions been susceptible to complete audit verification, the accompanying financial statements fairly summarize, in all material respects, the related complete financial statements in accordance with the criteria described in the Guideline referred to above.

These summarized financial statements do not contain all the disclosures required by Canadian generally accepted accounting principles. Readers are cautioned that these statements may not be appropriate for their purposes.
